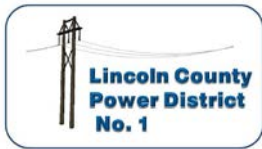

Program Requirements and Limitations

The program shall be available to all Irrigation, Small Mixed Agricultural Use, and Large Mixed Agricultural Use customers served directly by Lincoln County Power District No. 1.

To receive a rebate, representatives of Lincoln County Power District No. 1 must inspect the installation and verify that the irrigation efficiency improvement project is properly installed and operational.

Rebate will be applied against the electric account used for service of the irrigated field.

Rebates shall be offered for 11 specific sprinkler parts as listed in the incentive table. Rebates will be paid as credits on customer bills for electric service. Rebates shall be capped at \$1,000 per location during a 5 year period. Applicants will have six months from date of purchase to apply for rebates.

Applications for rebates will be reviewed and approved on the basis of the order in which eligible applications are received by Lincoln County Power District No. 1. The number of incentive payments to be issued each year is subject to the program budget limitation set by Lincoln County Power District No. 1. Applications received after funding limits have been reached shall be retained for consideration in the following year.
